The parties do hereby agree as follows:

Donor and others may make additional contributions and may choose to accelerate the scheduled payments; however, it is Donor's intent that Donor's gift shall be paid in full by **December 31, 2023**. The property comprising this gift may, for investment purposes, be merged with the general investment assets of MCS.

2. Purpose. It is Donor's hope that this gift shall serve as funding for the Bright Future Comprehensive Capital Campaign. The property comprising this gift, as well as any net investment income, realized gains and/or unrealized gains earned thereon shall be applied in support of this campaign which may include construction, remodel, furniture, fixtures, programming, scholarships, and legacy funding which are part of the Bright Future Campaign. All expenditures shall be made in accordance with MCS policies, procedures and guidelines then in effect.

3. Binding Commitment. This pledge agreement creates a binding obligation between Donor and MCS, upon which MCS is relying. The commitment to fund fully the gift is made in consideration of MCS's commitments to remodel the current facility, and in further consideration of the reliance by MCS and the reliance of other donors to MCS for the support of the Bright Future Campaign.

4. Amendment. By mutual written consent of MCS and Donor, Donor's legally or duly appointed agent or attorney-in-fact, any provision of this Agreement may be amended, modified, or deleted. Any such changes, deletions or additions shall be recorded in written addenda signed by the parties hereto, which shall form part of this Agreement.

5. Entire Agreement. This Agreement contains the entire understanding of the parties with respect to the subject matter of the Agreement and is subject to the laws of the State of California. This Agreement also supersedes all other agreements and understandings, both oral and written, between the parties relating to the subject matter of the Agreement.
